## What is the purpose of this update?

This document tells you how the Simplicity KiwiSaver Growth Fund (Growth Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Growth Fund provides investors with a limited exposure to income assets, but most of its investments are in growth assets. As a result, the return from the Fund is likely to be higher over the longer term (10 years or more) than the Balanced or Conservative Funds, but the value of its investments is likely to fluctuate more than the Balanced or Conservative Funds.

## What are the risks of investing?

## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Doris had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Doris received a return after fund charges were deducted of \$1,602 (that is 16.02% of her initial \$10,000). Doris also paid \$20 in other charges. This gives Doris a total return after tax of \$1,497 for the period.

The top ten investments make up 79.98% of the fund. The fund's exposure to assets denominated in foreign currencies was 68.84%, of which 71.19% was hedged. This means the fund's unhedged foreign currency exposure was 19.83% of the net asset value of the fund.<sup>2</sup>

## Notes

1. Other management and administration charges include a 0.01% estimated fee which covers administration costs incurred by the Vanguard underlying funds. This estimate is based on actual annual costs reported by Vanguard in its most recent annual report dated 30 June 2021 with additional details provided by Vanguard, and anticipated investment levels in the underlying funds in accordance with the Scheme's SIPO.
2. Our hedging policy is set using the average of the 12 main providers that we monitor, resulting in our international fixed interest and equity investments being 100% and 65% hedged into New Zealand dollars respectively. The hedging policy for equities is monitored quarterly and adjusted from time to time to follow the average within a range 50% - 70%
